In law school, he represented underserved D.C. residents in eviction proceedings as part of a student law clinic, and he now volunteers his time representing individuals facing eviction in Philadelphia. Before attending law school, Joe proudly served five years in the Marine Corps, where he learned Arabic and was selected for an elite Marine reconnaissance unit. He served in both Iraq and Afghanistan as a servicemember and civilian contractor.
